Pursuant to the Court's inherent authority to oversee discovery and the need to preserve the status quo pending a fuller evaluation of the issues, JAMS must preserve the mediator's notes from the parties' March 23, 2017 mediation session and all other documents related to the mediation pending further order of the Court. This order should not be interpreted as an indication that the Court has made any finding or determination as to whether the material will ultimately be found to be relevant or admissible; the Court is requiring the documents to be preserved so that such issues can be ruled upon based upon a full record at the appropriate time. In light of this order, <a href="#">8</a> plaintiff's motion to expedite consideration of plaintiff's emergency motion is denied as moot. SO ORDERED. Signed by Judge Amy Berman Jackson on 5/18/2017.
